

Terms of Use:

Welcome to The Liberty Lodge, owned and maintained by Willbloom Partners Limited. The Liberty Lodge provides wireless Internet access Service (the "Service") as it exists from time to time, to Customers who establish accounts with The Liberty Lodge or access The Liberty Lodge network from wherever it may exist. Unless explicitly stated otherwise, any new Service (as defined below), including the addition of new properties to the Service shall be subject to these Terms and Conditions.

When you are using any service or product available as a part of or as a supplement to the Service that does not have a separate legal agreement, the Terms and Conditions set forth here will apply. The Liberty Lodge may also supplement the Terms and Conditions with posted guidelines or rules applicable to specific areas of the Service. By using the Service, you agree, without limitation or qualification, to be bound by this Privacy Policy.

This policy may be updated from time to time without any notice, so please check back periodically.

1. What information does The Liberty Lodge collect?

The Liberty Lodge collects and stores your Internet Protocol (IP) address.

2. What are "cookies" and how does The Liberty Lodge use them?

In addition to the information described above, The Liberty Lodge also collects information "anonymously" using "cookies." A "cookie" is a small text file that is transferred from a Web site to the hard drive of your computer so that the Web site may track your activities while visiting the Web site allowing the Web site to provide personalized service and features.
